SECTION 8 – GENERAL CONDITIONS

1.	The Mineral Extraction Activities Application Form must be completed and submitted by the Applicant to the Landholding Corporation (LHC) at the latest sixty (60) days before the proposed start date of the Project.				
2.	The Application Fee is established at \$300.00 per parcel of Category I Land and is payable to the LHC either by cheque or electronic money transfer (EMT).				
3.	Upon receipt, the Mineral Extraction Activities Application Form will be reviewed by the Landholding Corporation (LHC), which reserves the right to accept or refuse any application at its sole discretion. Please note that submitting a completed application does not constitute permission to use or occupy Category I Land, nor does it authorize the start of any mineral extraction activities.				
4.	The LHC reserves the right to reject any Mineral Extraction Activities Application Form if the Applicant and/or their contractor has outstanding debts related to previous projects or Land occupation.				
5.	Any unauthorized use or occupation of Category I Land may result in legal action, including an injunction requiring the immediate cessation of all activities. The LHC may also hold the responsible party liable for restoring the Land and repairing any damages caused.				
6.	The Mineral Extraction Activities Application Form is used to request the allocation of a parcel of Category I Land, for the purpose of conducting mineral extraction and blasting activities, storing explosive materials and extracted granular. Please note that a Development Permit issued by the Northern Village is also required for any project taking place within municipal boundaries. The allocation of a parcel of Category I Land by the LHC in no way obligates the Northern Village to approve the project, nor does it ensure the project's compliance with municipal and provincial regulations.				
7.	Once the Mineral Extraction Activities Application Form is approved by the Landholding Corporation (LHC), a formal resolution will be issued by its Board of Directors to confirm acceptance. Please note that the role of the LHC is limited to authorizing the location of the site on Category I Land. Any mineral extraction activity remains subject to obtaining the appropriate environmental authorizations, permits, and lease rights from the relevant Québec ministries and regulatory authorities. The Applicant is responsible for ensuring compliance with all applicable provincial laws and regulations prior to commencing such activities.				
8.	Upon completion of the mineral extraction activities, the Applicant shall, at its sole cost, restore and rehabilitate the site in accordance with all applicable Québec government regulations, environmental requirements, and any conditions imposed by the competent authorities.				
9.	Any additional parcel of Category I Land required for temporary granular storage is allocated in increments of 929 m ² (10,000 ft ²) at an annual rate of \$30,000 per parcel or \$3,000 per month, depending on the chosen billing method.				
10.	The acquisition, extraction, mining, or exercise of any mineral or any subsurface rights on or under Category I Lands is permitted only with the prior consent of the LHC and upon payment of the applicable compensation for the use of such rights over the Lands.
